# **Remote Access Management (RAM)**



The RAM website provides information about your remote access management facility, as such, term is defined in the Merchant Agreement between you and the Fiserv entity providing Merchant Solutions. #### 1. Access

# 2. Information

  If there is any inconsistency between the information contained on the website and

the settlement amount that is deposited in your account, then the settlement amount deposited into your account prevails. You should verify all information contained on the website before you rely on it.

# 3. Liability

- (a) Except as set out in the next paragraph, Fiserv excludes all terms and warranties of any kind, express or implied, whether statutory or otherwise, relating in any way to the website, these terms and their subject matter.
- (b) Where any Act of Parliament implies in these terms, any term and that Act voids or prohibits provisions under a contract which exclude or modify the operation of such term, the term is taken to be included in these terms. However, Fiserv liability for breach of such term will, if permitted by law, be limited to (at Fiserv option): (i) resupplying the services; or (ii) the payment of the cost of resupplying the services.
- (c) Except as set out in the previous paragraph, Fiserv excludes all liability for loss or damage of any kind, however caused, in contract, tort (including negligence), under any statute or otherwise arising from or relating in any way to the website, these terms or their subject matter.

# 4. Termination
